

ABOUT THE LOSSAN RAIL CORRIDOR AGENCY

The Los Angeles – San Diego – San Luis Obispo (LOSSAN) Rail Corridor Agency (Agency) is a joint powers authority comprised of rail owners, operators, and planning agencies along the LOSSAN Rail Corridor. Since July 2015, the LOSSAN Agency has managed the Pacific Surfliner service under an interagency transfer agreement with the State of California.

The Orange County Transportation Authority (OCTA) serves as Managing Agency of the LOSSAN Agency, which is supported by 18 full-time staff members and shared OCTA resources. The Agency is governed by a Board of Directors composed of 11 voting members from nine member agencies representing rail owners, operators, and planning agencies along the entire rail corridor.

In Fiscal Year 2023-24, nearly 4.48 million trips were taken on the LOSSAN Rail Corridor, including 2.58 million on COASTER and Metrolink Orange County Line and Ventura County Line commuter service, and 1.90 million on the Pacific Surfliner service, making the Pacific Surfliner the busiest state-supported intercity passenger rail route in the nation.

BNSF Railway and Union Pacific Railroad freight networks operate on the LOSSAN Rail Corridor, providing a critical link in California's supply chain. The Corridor also parallels congested stretches of Interstate 5 and Highway 101, making it vital to the region's transportation system. Portions of the LOSSAN Rail Corridor are also a part of the Strategic Rail Corridor Network (STRACNET), which ensures the national rail network is ready to support defense deployment and peacetime needs.

LEGISLATIVE PRIORITIES

The LOSSAN Agency advocates for policies at the federal and state levels to improve rail operations, increase funding for operations and capital needs, and enable interoperability with connecting transit and rail services. An annual legislative program adopted by the LOSSAN Board guides these efforts. The LOSSAN Agency's 2025 legislative priorities include:

- Operational Funding: Maximize long-term, sustainable funding sources to support passenger rail operations and capital projects, including ensuring continued eligibility for the LOSSAN Agency to compete for state and federal funding.
- Infrastructure Investments: Continue to support resilient infrastructure and service improvement projects, including streamlining permitting for high-risk areas along the corridor.
- Advance Intercity Rail: Support efforts to advance intercity rail service to meet customer demand and enable future expansion.
- Regional Rail and Transit Connectivity: Support efforts to enhance connections between local transit services and regional and intercity rail along LOSSAN Rail Corridor.

The LOSSAN Agency was recently awarded \$27 million by the Federal Railroad Administration (FRA) to fund the operation of three additional roundtrips between Los Angeles and San Diego, increasing frequency to 13 daily Pacific Surfliner roundtrips and fully restoring service to levels that existed on the corridor prior to the COVID-19 pandemic.

RAIL INFRASTRUCTURE AND COASTAL RAIL RESILIENCY

Over 100 capital projects are currently in various stages of planning and development within the LOSSAN Rail Corridor. In 2024, the LOSSAN Rail Corridor was accepted into the **Federal Railroad Administration Corridor ID Program**, which establishes a pathway for infrastructure projects to access federal capital grant programs. The LOSSAN Agency is working with Caltrans on the implementation of the grant, which will include developing the scope, schedule, and budget for a Service Development Plan through Corridor ID and coordinating closely with stakeholders.

Addressing the resiliency of coastal rail infrastructure along three key segments of the LOSSAN Rail Corridor remains a priority of the capital program:

- Santa Barbara Subdivision: The LOSSAN Agency is working with Union Pacific Railroad to stabilize five areas on the north end of the corridor, where extreme weather and sea level rise have contributed to erosion of hillsides and bluffs immediately adjacent to the tracks and several critical bridge structures.
- Orange Subdivision: OCTA has secured \$305 million in state and federal funding for emergency coastal rail projects along a 7-mile OCTA-owned section. The effort includes riprap repair, catchment wall construction, sand nourishment, and trail restoration. In April and May 2025, the California Coastal Commission approved permits for three of four emergency areas. Construction began April 28, 2025, and the initial phase of the project was completed on June 6, 2025. At the same time, OCTA's Coastal Rail Resiliency Study will address medium-term needs, and the California State Transportation Agency agreed to lead long-term relocation planning.
- San Diego Subdivision: In 2024, the San Diego Association of Governments (SANDAG) began work on Phase 5 coastal bluff stabilization efforts in the City of Del Mar. SANDAG is also leading planning efforts for relocating tracks away from the eroding bluffs.
